

Case load of the Court since start of operation in June 2023 update end July 2024

I. Court of First Instance (as of 26 July 2024)

Since the Court's start of operations on 1 June 2023, the Court of First Instance has received a **total number of 447 cases.**


- a. Infringement actions and counterclaims
- 170 infringement actions are filed as follows:
 - o 67 infringement actions have been filed in Munich local division, 36 in Düsseldorf, 24 in Mannheim, 11 in Paris local division and 8 in Hamburg. The Nordic Baltic regional division, Milan local division and the Hague have received 6 infringement actions each. Brussels has received 2 infringement actions, whereas Helsinki, Copenhagen, Vienna and Paris central division have received 1 infringement action each.
- 192 counterclaims for revocation have been filed with the Court's local and regional divisions.
 This figure however gives an inflated impression unless it is noted that that each defendant in an infringement case needed up to a few months ago to file an individual claim for revocation. The 179 counterclaims for revocation come from 85 individual infringement actions (see graph below).
 - b. Provisional measures

The Court of First Instance has received **39 applications** for provisional measures, preserving evidence and orders for inspection.

c. Revocation actions

There is a total of 41 stand-alone revocation actions filed to date with the Court. Paris central division has received **36 revocation** actions, **4 revocation** actions have been filed with Munich central division and **1** with Milan central division.





A further **detailed breakdown of the total caseload** of the Court of First Instance is shown in the table below.

II. Court of Appeal (as of 31 July 2024)


To date, the Court of Appeal has received 4 appeals under RoP220.1 (*litera* a or b); 24 appeals under RoP220.1 *litera* c and 48 appeals under RoP220.2.

The Court of Appeal has also received **3 requests** for discretionary review, **8 applications** for suspensive effect and **21 applications** for an order for expedition of an appeal.

One application for rehearing under RoP245 has also been filed.

III. Language of proceedings (CFI only - all proceeding types)

It can be noted that **English** becomes the predominant language of proceedings with **51 percent**. As to **German**, it currently makes up **43 percent** of language of proceedings at the CFI. A further breakdown of language of proceedings can be seen below:
