About Mishcon de Reya

Mishcon de Reya was founded by Lord Mishcon in 1937 and the firm is regarded as part of the 'silver circle' of leading UK law firms. Anthony Julius, a partner at the firm represented the late Diana, Princess of Wales. in her divorce from King Charles III. The firm also acted for Gina Miller in two of the most high-profile judicial reviews in recent times. the first in 2016 in relation to parliamentary approval for triggering Brexit (Miller I) and the second in 2019 in relation to the legality of the Prime Minister's discontinuation of Parliament without dissolving it (known as prorogation) in Miller 2. The team won Case of the Year at the Lexis Nexis Legal Awards in 2020 for Miller 2. The cases are widely considered to be two of the leading constitutional law cases of the past 150 years.

Mishcon's Sports team advised on Marcus Rashford's contract extension at Manchester United, which will see his deal with the club run until 2028. The team, led by Simon Leaf and Tom Murray, worked closely with Marcus Rashford's representative, Dwaine Maynard of D N May Sports Management, during extension talks to secure a long-term deal for the player:

We undertake some of the most challenging, complex and high profile litigation, arbitrations, and other forms of dispute resolution across the world.

Akai Holdings

Representing the court-appointed liquidators in investigations and successful litigation in Hong Kong, England, Bermuda and the US arising from Hong Kong's then largest corporate collapse.

China Medical Technologies

Representing the Hong Kong and Cayman Island liquidators of China Medical Technologies, a NASDAQ listed medical technology company, which collapsed following the alleged theft of US\$500 million by senior management through concealed related party transactions.

3D-GOLD lewellery Holdings Limited

Representing the liquidator of the 3D-GOLD Group that collapsed with claims of over HK\$2.466 billion following the death of its Executive Chairman and the subsequent discovery that 810kg of gold bullion was missing. Pursued audit negligence proceedings against a Big Four accounting firm concerning the alleged misstatement of audited financial statements over many years.

Orient Power Holdings Limited

Representing the receivers of Orient Power, a major Hong Kong based electronics manufacturer that collapsed following the release of financial statements disclosing losses of over HK\$1 billion and a qualified audit opinion, in proceedings against the former auditors of the group concerning audits of five consecutive years.

Tenwow International

Representing the liquidators of Tenwow International, a Hong Kong-listed company of a group manufacturing and distributing food and beverage, in investigations and claims of approximately US\$500 million.

China Forestry

Representing the liquidators of a Hong Konglisted company purporting to own extensive timber plantations in Mainland China in ongoing proceedings against the former CEO. The company raised approximately US\$600 million in debt and equity in 2009 and 2010 and collapsed with no material realizable assets in 2015.

Other Major Projects include director liability and auditor negligence investigations, and litigation arising from the collapse of listed companies, including Blockchain Group, China Huishan Dairy, Centron Telecom International, China Fiber Optic Network System Group, Hua Han Health Industry, Hyflux, Samson Paper, Platinum Partners, Moulin Global, Ocean Grand, Sino Forest Corporation, Galleria Group and Sunlink.



Private Wealth and Family Disputes

We also enjoy strong relationships with most of the private banks and insurance firms to help serve their high-net-worth customers.

Our ability to unpick the complexities of cross-border relationship breakdown and work with lawyers and advisors in other countries ensures that difficult matters are dealt with smoothly.

Selected Cases

- Acting for the descendant of a wealthy local family in divorce proceedings which involved dynastic overseas family trusts set up by his grandparents in the 1970's which his spouse alleged was a nuptial settlement and resulted in the attempted joinder of the other beneficiaries
- Acting for an heir of a local prominent wealthy family in divorce litigation including a cross-jurisdiction dispute in Singapore and Hong Kong lasting seven years which involved assets in Hong Kong, Dubai and America
- Acting for a top Hong Kong tycoon in successfully opposing his former partner's claim for increased financial support of their children, including obtaining a judgment for separate representation of the children owing to the conflict of financial interest with their mother.

Arbitration

The relative ease with which arbitral awards can be enforced abroad, particularly when compared with High Court judgments, along with the confidential nature of arbitration proceedings have led to arbitration becoming an increasingly popular option for our clients. Karas So LLP has significant experience in domestic and international arbitration, with a team of specialists drawn from some of the world's leading international arbitration practices and institutions in Hong Kong, London, Paris, Singapore and The Hague.

Our team has resolved disputes across a range of industries by way of ad hoc arbitrations under the UNCITRAL rules and bespoke procedural rules, and institutional arbitrations under all the major institutional rules

Our team members have played a role in significant law reform initiatives involving international arbitration and private international law, such as the Hong Kong Law Reform Commission's report on Third Party Funding for Arbitration.

Selected Cases

- Representing the Respondents in a complex shareholders' dispute concerning US export control regulations as they apply to satellite technology;
- Representing the Claimant liquidators in a US\$150 million claim for auditor's negligence, arising out of the audits of a US-based hedge fund.



The Calibre of Our Work

One of the most rewarding aspects of the work I have done over the years at Karas So LLP is the calibre of the cases on which I have worked. Throughout my career, I have had the opportunity to work on some of the most significant, high profile and large scale commercial litigation being conducted in Hong Kong and abroad.

These cases commonly involve unique or novel points of law and are sometimes ultimately determined by the final appellate courts. This means you have an opportunity at Karas So LLP not just to apply the law as it is, but to have a hand in the development of the law. It is always fun to see a case you have worked on published in law reports, cited in text books and debated by academics.

Seeing the influence of our cases on the development of the law reinforces the significance of the work we do for our clients and for the practice of law generally. Being a firm rooted in Hong Kong, our cases also often feature Chinese elements, and are typically heavy in documents written in Chinese. Having the ability to read and write Chinese to an intermediate level has been an invaluable skill to have in almost all of my cases, and has opened doors that are otherwise shut to those without Chinese language skills.

Given the focus on disputes in Karas So LLP we do not rotate trainees between practice areas. Instead, we provide trainees with the range of experience required for qualification in Hong Kong within the context of our litigation practice. Specifically, we offer rotations between corporate collapse matters, acting for private clients and our family law practice.

Trainee salaries are benchmarked against market rates for other international firms in Hong Kong and reviewed each year.

An offer for a training contract is conditional upon the successful completion of the PCLL course in Hong Kong. We ordinarily expect candidates to complete a summer internship with us before making an offer for a training contract

If you secure an offer of a training contract with Karas So LLP prior to completing the PCLL, we will provide a maintenance grant during your PCLL studies and will cover your conversion exams and PCLL tuition fees. This support is conditional on you subsequently joining and completing your training contract with Karas So LLP.
